

Clarification on AAFES Shipping Requirements

Shipping Requirements

We receive numerous questions regarding compliance with purchase order shipping dates. Compliance charges generate when the contracted or delivery date is not met. EDI transmits both dates; the date you must meet depends upon whether you are FOB Origin or FOB Destination.

FOB Origin Example

If you are an origin supplier, you must meet the Contract Date ("**Contr.Date**"). In this example, the supplier must ship no sooner or later than February 15, 2008 to be in compliance.

FOB Destination Example

If you are a destination supplier, you must meet the Delivery Date ("**Del Date**"). In this example, the date is 8172. 8172 represents the year (8) followed by the numerical day of the year (172), in this case June 21, 2008. To be in compliance, the supplier must deliver the shipment no sooner/later than June 21, 2008.
